Memorandum of Understanding Between The Trustees of the California State University on Behalf of Cal Poly Humboldt And Cebu Technological University

This Memorandum of Understanding (MOU) dated 10 August 2022, sets forth the terms between The Trustees of the California State University on Behalf of Cal Poly Humboldt (HSU) and Cebu Technological University (CTU) to establish a Memorandum of Understanding for collaboration and partnership between both institutions.

The purpose of this MOU is to establish a formal partnership between Cal Poly Humboldt and Cebu Technological University for the purposes of collaborating and potential partnership on academic programs, faculty, staff, and student exchanges, service-learning, global education, and a commitment to engage discussion on additional partnership and/or collaboration opportunities. It is understood that a separate working committee composed of faculty, staff and/or students will be instrumental in the implementation of the finalized partnership and collaboration initiative(s).

This MOU is strictly for internal management use of each of the parties and shall not be construed to provide a right or cause of action or by any person or entity, and in no way restricts either of the parties from participating in any activity with other public or private agencies, organizations or individuals.

Further, this MOU is neither a fiscal, nor funds obligation, document. Nothing in this MOU authorizes or is intended to obligate the parties to expend, exchange, or reimburse funds, services, or supplies, or transfer or receive anything of value. The parties to this MOU will review the program one year prior to the expiration to ascertain whether Memorandum of Understanding will be renewed or if revisions are necessary.

Terms and Conditions

Term

This MOU shall be effective for five years from the date of signing.

Termination

This MOU can be terminated by either party at any time by providing notice in writing to the other party.

Amendment

This MOU may be amended by either party at any time by providing notice in writing to the other pally.

Notice

All notices, requests, demands, amendments, modifications, bills, or payments under this Memorandum of Understanding shall be in writing.

Exchange of value will depend on the type of partnership. Future terms of exchange will be mutually agreed upon by both parties. This value will be outlined in a new agreement or as an addendum to this MOU.

Authorization

Each individual executing this Memorandum of Understanding, or its counterpart, on behalf of the respective party, warrants that he/she is authorized to do so and that this Memorandum of Understanding constitutes the legally binding obligation of the entity which he/she represents.

Mutual Indemnification

Each party (individually herein as "Indemnifying Party") shall indemnify, defend, and hold harmless to the full extent permitted by law, the other party, its governing body, officers, agents, employees, and volunteers (collectively, "Indemnified Party") from and against any and all liability, loss, damage, claims, expenses and costs (including, without limitation, attorney fees and costs and fees of litigation) (collectively, "Liability") of every nature arising out of or in connection with Indemnifying Pruly's performance or failure to comply with any of its obligations under this Memorandum of Understanding, except such Liability caused by or arising from the sole negligence or willful misconduct of the Indemnified Party.
